ACCESS REGISTRATION AND ACKNOWLEDGEMENT OF RISK

1. I understand and accept that my entry onto the land and area operated by Blackmans Creek Holdings Limited (BCHL), (the Area) for the purposes of undertaking certain activities, including, but not limited to, cat skiing, alpine skiing, snowboarding, or other snow activities (whether for leisure, recreation, education, training or any other purpose) (the Activities), involves certain risks (both known and unknown) to myself and my property (including snow sports gear and other equipment that has been hired by me). I am aware that those risks could result in serious injury, disability, death or other physical or mental damage to myself or my property (including snow sports gear and other equipment that has been hired by me). In spite of these risks, I choose to undertake the Activities in the Area and expressly assume the risk of any injury, disability, death or other physical or mental damage to myself or my property (including snow sports gear and other equipment that has been hired by me) that may arise as a result of my undertaking the Activities in the Area.

2. I acknowledge that any injury, damage or loss to myself or my property (including snow sports gear and other equipment that has been hired by me) that occurs during or in relation to my undertaking any Activities in the Area is not the responsibility of BCHL and that BCHL takes no responsibility and assumes no liability for any of my acts or omissions, or the acts or omissions of any third parties.

3. I understand that my undertaking of the Activities in the Area necessarily involves the exposure of myself and my property (including snow sports gear and other equipment that has been hired by me) to potentially harsh conditions (including, but not limited to, extremely cold temperatures, snow showers, strong winds and limited visibility) which can change quickly and without warning. I confirm that I am dressed appropriately for these conditions and that any snow sports gear or other equipment I am intending to use for the purposes of the Activities is my sole responsibility and is fit for such use.

4. I release, waive, discharge and hold harmless BCHL, its directors, officers, agents, representatives, contractors and employees from all claims, losses, damages or expenses (including legal costs) that may be incurred during, in relation to, or which arise out of, my undertaking the Activities in the Area.

5. If I do not hold residency in New Zealand, I declare that I will not attempt to avoid clauses 1 to 4 of this document by commencing legal action in any jurisdiction other than New Zealand.

6. I confirm that I am physically fit and am not suffering from any disability, illness or any other condition that may affect my undertaking of, or otherwise increase the risks associated with my undertaking of, the Activities in the Area. I further confirm that I possess a sufficient level of skill and experience to enable me to undertake the Activities.

7. I agree to follow all instructions of BCHL, any third parties and their respective employees at all times during the time that I am in the Area.

8. I understand that BCHL reserves the right (in its sole discretion) to restrict or prevent access to the Area at any time due to potential hazards, unsafe conditions, inclement weather or because of any other unforeseen event or circumstances which may arise.
